# 1 PRODUCT DESCRIPTION

Waterbased careoil on a natural basis.

- For the initial care and refreshing of all oiled wood and cork floors.
- Gives the floor a pleasant satin-matt look.
- Regular cleaning of the refreshed wood or cork floor is made easier with Dr. Schutz Wood Care.
- Provides optimal protection.

**H2Oil white** is the white pigmented variant for white oiled floors.

### 2 AREAS OF APPLICATION

For oiled wood and cork floors with a factory applied or professionally applied finish. Please pay attention to the care instructions specific to the floor.

# 3 APPLICATION

For post installation cleaning and slightly dirty wood or cork floors, clean beforehand with **Dr. Schutz Wood Care** in combination with a green pad. In the case of very dirty floors or footfall routes, carry out intensive cleaning in advance with **Dr. Schutz Wood Floor Deep Clean**, in a ratio of 1:1 up to 1:3 diluted in water, using a green pad.

After the surface has dried completely, apply initial care, or a refresher coat with **H2Oil**. Before use shake up the **H2Oil** thoroughly. Then apply undiluted with a dry polish applicator, or with a dry, fluff-free wide mop, in a thin, even film on the stripcleaned floor. Allow the area to dry for at least 12 hours before use, or more appropriately overnight.

#### Please note:

- Avoid strong sunlight and draughts during application.
- Switch off underfloor heating well in advance.
- Rinse the mop used directly after use in clear water, subsequently clean thoroughly with a cleaning solution (e.g. an intensive cleaner).

# 4 CONSUMPTION

Approx. 20-25 g/m<sup>2</sup> per application, depending on the absorbency of the surface (Range: 40 – 50 m<sup>2</sup>/l).

# 5 DRYING TIME

12 hours, or overnight.

Low temperatures, increased humidity and poor ventilation can prolong the drying time significantly.

# 6 STORAGE

Protect against frost. Store in a cool, dry place. Will keep for 24 months in unopened original canister from the date of manufacture. Keep cleaning materials out of the reach of children.
