

Laminate Cleaner



1 PRODUCT DESCRIPTION

Mild neutral cleaning agent for the initial and regular cleaning of laminate floors. Removes dirt, fat, grease and shoe marks. Does not leave a residue. For EN 13329-defined laminate floor coverings and laminate surfaces (including kitchen and bathroom furniture). Specifically developed for all click-laminate floors.

- Special formula neutralises unpleasant odours (e.g. cigarette smoke) and ensures better indoor air if used regularly.
- Better edge protection.
- Recommended in the EPLF (European Producers of Laminate Flooring) publication concerning the cleaning and maintenance of lamiante floorings.

2 AREAS OF APPLICATION

All kinds of laminated floors and surfaces (e.g. furniture in kitchen and bathroom).

3 APPLICATION

Dilute Laminate Cleaner in a ratio of 1:200 (50 ml to 10 l of water) and lightly damp wipe over the floor with this solution. For larger surface areas use a dilution up 1:200 to 1:400 using the spray-cleaning method in combination with a monodisc machine such as the SRP 1 plus a white or red pad. Glue residues and stubborn stains can be removed with Elatex Universal Stain Remover.

Note: Laminated floors or surfaces should never be damp or wet for a longer period of time. Especially the edges could swell up and change shape. Therefore always wipe with thoroughly wrung-out cloths and ensure that no "pools" are created on the floor.

5 STORAGE

Laminate Cleaner should be stored in a cool, dry place in its closed original container. Protect from frost. Keep locked up and out of the reach of children.

6 TECHNICAL DATA

Data on ingredients (EC recommendation): less than 5% anionic surfactants, non-ionic surfactants. Contains BENZISTHIAZOLINONE, METHYLISOTHIALZOLINONE, perfume, CITRAL, LIMONENE, LINALOOL, solvents. Product code for cleaning and care products (Giscode): GU 50 pH: approx. 7.5 (concentrate) ADR/RID: not a dangerous good as defined by transport regulations. CLP: The product is not classified according to the CLP regulation.
