

Wood Floor Deep Clean

1. PRODUCT DESCRIPTION

Gentle special stripper. For removing old residues of wipe-over care products and polymer dispersion films on wood and cork floors. For intensive cleaning of oiled and waxed floors. For residential and commercial applications.

- Neutral cleaner without care effect based on highly effective surfactants and alcohols.
- Removes stains and shoe marks.

2. APPLICATION

Remove coarse dirt by sweeping or vacuuming. Mask off adjacent surfaces cleanly and protect from wetting. When used on lacquered floors, apply undiluted to the floor with a wide mop and scrub with a green pad. Take up the dirt water and immediately wipe with clear water until damp. Dilute 1:3 with water before applying to oiled floors. For strip cleaning of lacquered wood floors, keep the amount of water and contact time low due to the risk of run-ins and spotting. After stripping, a floor must be re-treated.

Please note:

- If possible, clean in pairs, with the first person dissolving the care film and the second immediately vacuuming up the resulting dirt.
- It is recommended to work with a mono-disc machine, on smaller surfaces also with the Padmaster.
- When using the Floorboy, fill the tank with the cleaning solution and clean the surface with the green pad.
- Prolonged exposure of water-based lacquers to the product can lead to the temporary formation of milky stains. Therefore, keep the exposure time to a minimum and never leave the floor wet for a longer period of time.

3. CONSUMPTION

100 ml/m² (10 m²/l).

4. STORAGE

Store in a cool dry place. Keep out of the reach of children.

5. TECHNICAL DATA

Ingredients: water / less than 5% non-ionic surfactants, anionic surfactants / perfumes LIMONENE / Alcohols
GISCODE GU50 (daily cleaning agent, containing solvents, unmarked)(Germany)

- If it is not possible to remove an old and excessively thick care layer, the much stronger products Dr. Schutz Clean & Strip or even Dr. Schutz Turbo Strip can be used. These products are only recommended for experienced users. In individual cases, lacquer dissolution or wood discolouration may occur.
- In individual cases, depending on the individual conditions, wood discolouration starting from joints due to the effect of water is possible.
