2 AREAS OF APPLICATION

To be applied in the final coating for the basic treatment of sanded wood and parquet floors, as well as cork floors and OSB boards with **euku premium hardwax oil +**.

3 APPLICATION

Add to the euku hardwax oil + system in a ratio of 1:10 and mix together. Work with the mixture as described in the system.

4 CONSUMPTION

approx. 4-5 ml/m² (range: 10-12 m²/l) for single application in the top coat.

5 DRYING TIME

As described for the euku hardwax oil + system

6 CARE & MAINTENANCE

As described for the euku hardwax oil + system

7 STORAGE

24 months in unopened, original canister. Store in a cool, dry place. Keep out of the reach of children.
