1 PRODUCT DESCRIPTION

Waterbased lacquer primer with warm accentuation of the woods color.

- Roller primer for wood and cork floors
- Especially recommended for priming on exotic wood species.

2 AREAS OF APPLICATION

For priming wood and parquet floors before finish with strato lacquers.

3 APPLICATION

Shake up strato intensive prime 201 well! Apply evenly and generously with the strato-Roller.

Please note:

- The subsurface must be professionally sanded and grouted before application and must be clean and dry, free of oil, wax and dust.
- In order to remove the water, accelerate drying and reduce moisture in the wood, we recommend using the **Dr. Schutz Drying Fan TG1**.
- Wood which has largely been dried from below (e.g. in renovation sanding on an under-heated floor) should be wet-mopped before lacquering, in order to avoid colour marks in the process.
- Room and material temperature must not fall below +15°C during application and drying time.

4 CONSUMPTION

approx. 80-100 ml/m² per coat (10-12 m²/l).

For best results and an even surface image, work in thick layers. In the case of highly absorbing wood increased consumption is possible.

5 DRYING TIME

Can be walked on carefully and worked on again after evaporation of water, approx. 1-3 hours (at 20 °C, 50% relative humidity and air movement).

In order to avoid excess soaking of the wood, only one rolled coat of water-based lacquer is recommended per day. Low temperatures, increased humidity and poor ventilation can prolong drying time substantially.

7 STORAGE

Protect from frost. Store in a cool dry place. Can be stored for 12 months from date of manufacture in unopened original canister. Keep coating materials out of the reach of children.

If stored in changing temperatures and in opened canisters, dry parts can form. Filter these out with a sieve before using.

Contains substances: water, polyacrylates, silicic acid, glycol ethers, additives.

- Please pay attention to the printed batch number. Only use products with the same batch number in one layer. In the case of a different batch, mix this in a separate container before using.
- The used roller can't further be used with other strato qualities.
- strato intensive prime 201 can't be mixed with other strato qualities.
- Clean working tools with water. We recommend that you leave the well-washed roller fully covered in water, in order to avoid it drying out. However, when the roller is used anew for application, no water must be allowed to mix with the lacquer.
- It is possible to apply the product to all types of wood. In the case of exotic woods, their characteristic appearance may be affected by the specific properties of the wood. We recommend testing beforehand.
